- Chandigarh, June 3- Haryana Government has launched a dedicated portal, 'Haryana Udhya Sahyog', to capture the Micro, Small and Medium (MSME) grievances in obtaining loans. The portal aims to enable MSMEs in Haryana to take maximum benefits under the 'Atmanirbhar Bharat Abhiyan' economic package.
- Sharing more details about the same, a spokesman of Industries and Commerce Department said that while

understanding the severity of challenges posed by COVID-19 Pandemic, this portal aims to help the MSMEs in facing financial duress due to this Pandemic.

- The spokesman said that for registering a grievance, an entrepreneur has to Log on to Saral Haryana Portal (<https://saralharyana.gov.in>) and fill up the grievance form available on the portal and submit the same.
- He said that all the entrepreneurs in the State should come forward and take maximum possible benefits of the Government of India programmes and report the credit related challenges faced through the portal. All grievances reported would be followed with the banks on a daily basis and will be resolved in an expedited manner.
- The Spokesman said that economic impact of the COVID-19 pandemic in India has been largely disruptive. MSMEs across the nation are facing financial duress due to the pandemic. The Government of India launched an ambitious 'Atmanirbhar Bharat Abhiyan' economic package to provide credit facilities to industries. Economic package covers all the MSMEs as per the revised definitions as well as retailers, traders, shops etc, while understanding and acknowledges the severity of challenges posed by this pandemic, Haryana Government has also launched this portal.
