Order

In continuation with the earlier order PS/ACSH/2020/9351 dated 20.03.20 and in exercise of powers conferred under 'The Haryana Epidemic Disease, COVID-19 Regulations, 2020' notified under Haryana Epidemic Disease Act 1897, following directions are hereby issued in the State of Haryana with immediate effect:-

- Unnecessary Gatherings of people in Hospitals is prohibited and Police may be deployed to manage the same. Thermal Scanner is to be used for segregation of all patients visiting Hospitals.
- Triage area may be identified near the URI corner which is already instructed to be set up in all Hospitals.
- OPD of Dermatology (Skin), Eye, Orthopedics, Surgery, Physiotherapy, Psychiatry and Dental etc is closed till 31st March 2020.
- OPD of Gynecology, Paediatrics, Medicine/Chest etc is to be continued.
- · Sanitize all the Hospitals as per protocol regularly.
- Pharmacy counters may be increased & queue management system to be followed by engaging Indian Red Cross Volunteers.
- The protocol of only one attendant per indoor patient be strictly implemented and the
 visiting hours may be so staggered that there is no crowding in the wards and the formula
 of attendants of odd/even beds to be allowed in a particular ward at a particular time may
 be adopted.
- Hospitals may ensure that stable patients are discharged as early as possible while further new admissions (of stable patients) are also restricted.
- Increase the deployment of Doctors and Para Medical Staff in Emergency.
- The Medical & Paramedical staff is advised to strictly follow the guidelines.
