**NOTIFICATION**

Ministry of Home Affairs' Order No.40-3/2020-DM-I(A) dated 29.06.2020 dungzuiin Mizoram Sawrkar pawhin inkarkhip burna chu tlema thlah zalen deuhin Order dated 30.06.2020 a ti chhuak a. Ni 25.05.2020 atanga thlawhna service te chhunzawm anih bakah State chhunga veivah khapna-te hlih anih takah chuan mipui tan zin veivah pawh a lo awlsam chho leh ta a. Hei avang hian State pawn atanga lo lut leh Mizoram mi leh sa zin chhuaka lo haw leh te pawh an thahnem chho zel a ni. Chutih rualin Mizoram mi leh sa State pawn tangkhang te pawh lak luh kim thawkhat an ni ta bawk a. Chuvangin, hnathawhna leh mimal tul thila State chhunga rawn lut leh zin chhuaka lo let leh te quarantine leh an hriselna enfiahna kawnga Sawrkar a insenso reng chu tul tawh lova hriat ani. Chuvangin, **he thu chhuah ni atanga thu leh awm hma** chu State pawn atanga Mizoram rawn lut te chuan an quarantine leh test senso chu an intum ve tawh anga, a kalphung tur erawh chu hetiang hi ani ang:

**Category A**

Mizoram mi leh sa, State pawnna hna ng het ni lo thawk (migrant worker a chhiar), an hna atanga an thlawn avanga la tangkhang, **31.07.2020** ral hma-a Mizorama lo haw te; tin, chhan dang vanga COVID-19 lockdown hma atanga Mizoram pawnna awm, **31.07.2020** ral hma-a Mizorama lo haw, sum leh paia harsatna tak tak nei, Deputy Commissioner te'n an hriatpuite leh inentira zin chhuak (medical referred case) te erawh chu he Order hian a huam lovanga, Sawrkar quarantine facility-a awm te enkawl dan kal mek anga enkawl an ni ang.

**Category B**

Hei hian Mizoram mi leh sa leh hnamdang, Mizoram chhunga cheng te zawng zawng a huam ang. Heng mi te hi a tlem berah ni 14 (sawm leh pali) chhung Sawrkar quarantine facility buatsaih ah an awm anga, an thlen man, ei leh in leh COVID-19 test-na man zawng zawng chu anmahni emaw an sponsor (hnamdang, ILP mamawh tan) ten a hnuiaia tarlan ang hian an chawi ang.

Quarantine facility-a an luh dawnin ni 14 chhung ei leh in leh riah/thlen man chu Deputy Commissioner hnenah an pe lawk tur a ni.

## **Category C**

Hei hian Mizoram pawn lam mi, an hnathawhna avanga lo zin ngai te, Central Sawrkarin official duty-a a rawn tirh te leh Mizoram Sawrkar, company, pawl leh mimal te'n an mamawh avanga mithiam bik an chah chhuah, hun rei lo te cham tura rawn zinte a huam ang. Sawrkarin an awmna tur bik hotel emaw thlenna dang a ruahman chauhah an tleng thei anga, an thlen man leh ei leh in man, veivahna leh test-na man te chu anmahni emaw, anmahni chah chhuaktu te'n an tum ang.

Quarantine facility an thlen veleh COVID-19 test an paltlang anga, an negative chauhin an rawn kal chhan hna chu an hawk tan thei ang. An cham chhungin an tlawh tur site/office ruat lawk ah chauh kal phalsak an ni anga, hmundanga veivah leh midang nena intlawhpawh erawh phalsak an ni lovang. An thlenna hmun ruat atanga an tlawh tur hmuna an veivahna tur lirthei chu a hranpain anmahni chah chhuaktu te'n Deputy Commissioner rawn chungin uluk takin an ruahman anga, an mahni duhthu-a lirthei lo ruahman ve a rem lovang.

## **Category D**

Hei hian hmasawnna ruhrel siam hna (infrastructure development project) kal lai avanga Public Sector Undertaking, construction company leh contractor ten Mizoram pawn lam atanga hnathawktu tur an chah chhuahte a huam ang. Hemi category hnuia mite chu an hnathawhna hmunah in quarantine-na tur remchang a awm anih chuan an awmna Deputy Commissioner te hriatpuinain ni 14 chhung an in quarantine ang. Amaherawhchu, an in quarantine dan te, a hunchhung an vawn chungchang leh an hmunhma an tih thiaghlim dan chungchangah Sawrkarin Standard Operating Procedure (SOP) hrang hrang a duan te chu Deputy Commissioner leh Health & Family Welfare Department te'n an hrilh hria anga, an zawm leh zawm loh chu uluk takin an endik thin ang. Quarantine facility siam nana senso zawng zawng chu, an ei leh in leh COVID-19 test-na man tiamin, anmahni enkawlta company emaw a contractor te'n an tum ang. In quarantine-na tur hmunhma leh building te an nei remchang lo anih chuan Category 'B' ang hian quarantine tur an ni ang.

## **Category E**

Mahni senso-a nuamsa deuh zawka ni 14 chhung quarantine-a awm duh te chu he category hian a huam ang. An awmna tur hotel emaw thlenna dang Deputy Commissioner te'n an ruat lawkah chauh an awm thei anga, an thlen man leh ei leh in man chu Deputy Commissioner te'n hotel/thlenna nei tute be rawn lawkin an fix ang. Heng hotel/thlenin te hian mikhual dang an tleng thei lovang a, an hotel an tih thiaghlim dan tur te, mikhual an enkawl dan tur leh an hnathawk/staff te zawm tur kaihruaina Sawrkarin a siam zawng zawng te chu khauh takin an zawm tur a ni.

## **Lengpui airport atanga in lam dan chungchang**

Thlawnha-a Lengpui airport rawn tleng te reng reng chu, Aizawl-a tawp tur an ni emaw district dang la pan zel tur an nih pa'whin, Sawrkarin lirthei a ruahman (empanelled taxi/rented car) emaw anmahni motor, uluk taka driver

nena indaidanna siam-ah te chauh lam theih an ni ang. An chuan man (fare) erawh chu Deputy Commissioner, Aizawl in rate a siam angin passenger in a tum ang. An thlenna tur quarantine facility emaw district dang la pan zel tur, Aizawl-a riah lailawk ngai te tan Transit Quarantine Facility an thlen hma chu khawiah mah an ding khawtlai tur ani lovang.


