ORDER

The approval of the Competent Authority is hereby conveyed for setting up of 500 bedded COVID facility at Main Ram Lila Ground, Delhi Gate, Near LNH hospital and Ram Lila Ground near GTB Hospital having facilities similar to the COVID facility set up by DRDO near IGI Airport. The above facilities will be linked to Lok Nayak Hospital and GTB Hospital respectively. The Medical Directors of LNH & GTB Hospitals are accordingly directed to :-

1. Procure & provide all consumable items as per requirement for the 500 bedded facility.
2. Make available semi fowler beds, oxygen concentrators, Bipap etc . The same may also be considered to be requisitioned by sending Email to dshmspo1@gmail.com, dshmlogistics@gmail.com, dshmspm@gmail.com
3. Coordinate with CATS for arranging ambulances.
4. Make provision of Nurses, GDA and Sanitation staff as per requirement. Empanelled Nursing Staff, who are currently on waiting list of Mohalla Clinic, can also be hired for the CCC, who will be paid at par with ANMs already working in Mohalla Clinic.
5. Make arrangement for Specialists/GDMOs etc

Medical Directors of LNH & GTB Hospitals are hereby directed to make all arrangements using powers u/s 50 of Disaster Management Act, already delegated vide order No. 52/DGHS/PH-IV/COVID-19/2020/prsecyhfw/ 144400-14449 dated 20.06.2020.
