## Minutes of Meeting of the State Executive Committee held in the Forest Bhavan, on 23st April, 2020

On 23/04/2020, a meeting of State Executive Committee (SEC) was held under the Chairmanship of Chief Secretary (also Principal Secretary, PWD), Goa and the following other members of the SEC also attended:

- 1. Shri Puneet Goel, Principal Secretary, Science and Technology
- 2. Shri S.K. Bhandari, Secretary, Transport
- 3. Shri Sanjay Kumar, Secretary Revenue, Member Secretary, SEC & SDMA

The SEC was briefed about the reports on Law & Order, Trucks Movement, Relief & Shelters, and Covid Status Report (copy attached).

The other officers (as per the list Annexed), also attended the meeting as special invitees.

After deliberation on the current situation, the SEC noted and decided the following:

- 1. Status of COVID19: Secretary Health informed that no new Covid-19 case has been detected after 3rd April 2020. As on date, Goa has had seven positive cases of Covid-19, and all seven patients have recovered. After recovery, these patients are shifted to a Quarantine facility outside the Covid Hospital. 49 tests for Covid were done during the last 24 hours, on SARI/ILI patients, all of which were negative. The SEC noted with caution that Goa had not yet faced any community transmission.
- 2. Secretary, Ports informed that three ships carrying goan crew are about to berth in Mumbai or may come to Goa. After testing negative, these seafarers would come to Goa and would be housed in the paid Quarantine facilities. He informed that he has been able to negotiate the room rentals with food from a couple of hotels for their quarantine, in coordination with the Collectors. Secretary, Tourism also shared the price offered by the TTAG. The SEC observed that the negotiated prices be shared with the employer company, who would be free to further negotiate or get a better deal in any other suitable hotel. As per Cabinet decision, the employer company has to pay for these quarantine facilities. Secretary, Fisheries further informed that the crew of Marella Discovery have already disembarked and are undergoing testing.
- 3. The SEC asked Secretary Law to work out a mechanism to start the process of registration of documents by the Registration department. A staggered and gradual approach be adopted while following all safety norms such as social distancing, use of sanitizer, hand wash, etc for the registration of documents. This would also help people meet the requirements of statutory limitation period, as permitted for registration of the document after their execution, and enable revenue for the Govt.

- Secretary, Health informed that the Health department has collected 40 samples so far, based on the recommendation of the expert committee headed by Dr Jagadish Cacodcar, Professor and Head of the department of Preventive and Social Medicine, GMC after the House-to-House survey.
- Secretary, Health informed that the Health department has constituted teams and set up four Kiosks at MPT to take samples for Covid testing, of the seafarers who would land at MPT. The SEC advised all concerned to be prepared for the arrival of seafarers in the State.
- 6. Secretary Health further informed that the department has finalised the protocol to deal with requests for inter-state movement on medical emergencies. As planned, the team of health experts would sit in the Collectors' office to scrutinise the applications. The GEL has made the necessary changes in the existing application to enable the scrutiny. So far, 16 applications have already been received.
- 7. PCE (PWD) informed that 51 ongoing works have restarted. He also informed that the water supply from Salaulim has become normal. The IGP shared the information received about the complaint of the quality of water being supplied at Mapusa. The SEC directed the PCE(PWD) to examine the information for remedial action.
- 8. CE(Electricity) informed that the power supply is normal in the State. For providing uninterrupted power supply at the border checkpost, he suggested the use of Inverters. The SEC advised him to give a report with justification by tomorrow.
- 9. Director, IT informed that data is being entered on all border checkposts. The changes sought by the IGP would be soon done in the Web Application. The SEC asked Secretary Health to examine if the health data could also be captured in the same application. Director, IT also informed that she has granted Travel permits for the employees of 54 IT and ITES companies.
- 10. Commissioner (Excise) informed that the liquor manufacturers have produced about 3.11 lakh liters of hand sanitisers. The Excise department has also seized unauthorised stocked liquor worth 66.56 lakhs at Ponda.
- 11. Secretary, Civil Supply informed that the supply of essential items is normal.
- 12. The SEC clarified that booking at the circuit house should not be done without the approval of the Collector.
- 13. Shri CR Garg, District Observer visited the border check post at Mollem. He was satisfied with the current arrangement. He also visited a police picket around 2 KM away from the main checkpost. He observed that adequate police is deployed to check the unauthorised movement through off road tracks.

- 14. Secretary, Panchayat informed that Panchayat Secretaries have already issued 49 permissions for the self employed category of permitted activities as per the MHA's guidelines. DMA also informed that municipalities have started giving such permissions.
- 15. The Nodal Officer for Quarantine facilities informed that a total of 78 persons are sheltered in five quarantine facilities. At Acron Homes at Candolim only one person remains. He is visiting these facilities regularly.
- 16. IGP informed that police have conducted several meetings with the local community, including the Mosque Committee to sensitize them about the norms of social distancing and other directions of the MHA, in view of the upcoming Ramzan period. The SEC also asked the Secretary, Civil Supply to run Groceries-on-Wheels services, if required, for meeting the specific demands of the community during the festivities. However, the SEC reiterated the MHA guidelines on gatherings.
- 17. CE, WRD informed that the department has restarted 24 out of the 47 ongoing works.
- 18. PCCF informed that directions have come from the Central Government that no tourism activity to be allowed in tiger reserve areas. He added that the department has already banned tourism activities in view of the Covid19 lockdown and the ban continues.
- 19. Shri Keshav Kumar, District Observer informed that he visited the area to verify the facts regarding the opening of the shops at Mapusa, as reported in a newspaper. However, on inquiry, he found that most of the shops that were open were in the permitted category. The SEC asked the IGP and Incident Commanders to strictly enforce the MHA guidelines.
- 20. The Labour Commissioner informed that he received information about 18 labourers trying to cross the border on foot. They were picked up and taken to the nearest Shelter Home.
- 21. Director, Transport informed that the KTCL operated 154 buses and carried 1944 passengers in the morning shift, consisting of Government servants and healthcare workers.
- 22. Secretary Health informed that as per IMA, 484 private health institutions have started functioning.
- 23. Secretary, Agriculture informed that the agricultural activities are normal. With the 12 Harvester currently in use, about 65 % harvesting is already complete in the State. The SEC asked him to extend all possible help to the farmers.



Committee also conveyed to all concerned that as per MHA orders, any person violating these containment measures or not complying with the above directions will be liable to be proceeded against as per the provisions of Section 51 to 60 of the Disaster Management Act, 2005, besides legal action u/s 188 of the IPC.
