Major Activities undertaken by the State of Haryana to control the spread of COVID-19

- Department of Health fixed the per day upper cap of COVID treatment charges in all private hospitals through order dated 25.06.2020. The rates for isolation beds (Rs. 8, 000 per day for Non- NABH Hospitals, Rs. 10, 000 per day for JCI/ NABH Hospitals), ICU Beds without Ventilators (Rs. 13, 000 per day for Non- NABH Hospitals, Rs. 15, 000 per day for JCI/ NABH Hospitals), ICU Beds with Ventilators (Rs. 15, 000 per day for Non- NABH Hospitals, Rs. 18, 000 per day for JCI/ NABH Hospitals).
- State Government has fixed the Rates/ Charges for different type of COVID 19 testing as below:-
 1. CBNAAT testing- 2400/-.
 2. True NAT Testing- 1250/-
 3. RTPCR Samples collected at private hospitals/ labs and their designated collection centers - 299/-
 4. RTPCR Samples collected through home visits - 499/-
 5. Rapid Antigen Testing-350/-
 6. IgG based ELISA Testing-250/-
- The Government of Haryana has fixed the upper limited of lab test in patients of COVID-19/ post-COVID sequelae, as tabulated below:-

- Haryana Village General Health Checkup Scheme: The scheme was initiated from May 15, 2021 & villages with high COVID load were taken on priority and Rapid Antigen Testing (RAT) was the main stay of screening. Till date, total 1,73,79,228 were screened and 1,10,928 cases of ILI were detected and 5,164 positive cases were diagnosed, isolated and treated to prevent the spread of disease. The villages with positivity more than 5% were re-screened. Out of 13,22,058 people re-screened, 90 positive cases were detected and treated to effectively curtail the spread Total 2637 number of Plasma Units collected from COVID 19 recovered patients till date and 1738 COVID 19 Patients given Plasma Therapy treatment till date.
- Total 2495 number of Plasma Units collected from COVID 19 recovered patients till date and 1622 COVID 19 Patients given Plasma Therapy treatment till date.
- Control Room –cum- Helpline of 30 lines has been made operational at Panchkula. Services of tele-medicines are being provided through helpline. The helpline nos. are 8558893911, 1075 and 108 (Ambulance Services) available for 24 X 7.
- The State Government notified ‘The Haryana Government Epidemic, COVID-19 Regulations, 2020’ under the Epidemic Disease Act 1897 on 11th March 2020.

Ltd., Panchkula (1500 sample per day), Spice Healthcare Pvt. Ltd., Gurugram (25000 sample per day), Pathline Labs Private Limited, Sec-63, Noida, UP (3500 sample per day), Life Cell International Pvt. Ltd., Gurugram (3000 sample per day), Hindustan Wellness Lab, Gurugram (6000 sample per day), CNC PathlabJhandewalla, Delhi (2500 sample per day), NC Medical College, Israna, Panipath (750 sample per day), AL FALAH Medical College Faridabad (400 sample per day) and Genestrings Diagnostic Centre, Delhi (4000 sample per day), Genestore Lab, Gurugram(40000 sample per day), THS Diagnostics, Okhla, New Delhi, Delhi(1000 sample per day), NKV Path Lab, Gurugram(2000 sample per day), Molecular Lab, Sarvodaya Hospital, Faridabad(1000 sample per day), Geneix Satya Laboratories, Faridabad (2500 sample per day), Med Source Ozone Biomedicals Pvt. Ltd., Faridabad (2000 sample per day), Pro Path Lab, Mayur Vihar, Delhi (2000 sample per day), Labcure Lab Pvt. Ltd., Rohini, Delhi (2000 sample per day), are doing test for COVID-19.
- More than 88.70lac persons have already downloaded AarogyaSetu App in Haryana.
- More than 20 Mobile Health Teams have already been formed to check health status regarding SARI, ILI etc.
- Haryana has 41,412 bedded quarantine facilities in Dedicated COVID Care Centers and 23,780 Beds are available in Dedicated COVID Hospitals and in Dedicated COVID Health Centers.
- Department of Ayush has distributed immunity boosting medicines to more than 12.19 lac persons in containment zones.
- Monitoring of Home Isolation Kits Distributed as on 1st December 2021: 38004 (Details provided by National Health Mission, Haryana).
- **Sero Survey-** Health Department, Haryana has conducted 3rd round of Sero Survey in the month of September 2021 in the State, wherein Seroprevalence was found to be 76.3 % (Urban 78.1 % & Rural 75.1 %). In previous 2 rounds, the Sero prevalence was found to be 8% in 1st round and 14.8% in 2nd round of Sero Survey.
