#### Major Activities undertaken by the State of Haryana to control the spread of COVID-19

- Department of Health fixed the per day upper cap of COVID treatment charges in all private hospitals through order dated 25.06.2020. The rates for isolation beds (Rs. 8, 000 per day for Non- NABH Hospitals, Rs. 10, 000 per day for JCI/ NABH Hospitals), ICU Beds without Ventilators (Rs. 13, 000 per day for Non- NABH Hospitals, Rs. 15, 000 per day for JCI/ NABH Hospitals), ICU Beds with Ventilators (Rs. 15, 000 per day for Non- NABH Hospitals, Rs. 18, 000 per day for JCI/ NABH Hospitals), ICU Beds with Ventilators (Rs. 15, 000 per day for Non- NABH Hospitals, Rs. 18, 000 per day for JCI/ NABH Hospitals).
- State Government has fixed the Rates/ Charges for different type of COVID 19 testing as below:-
  - 1. CBNAAT testing- 2400/-.
  - 2. True NAT Testing- 1250/-
  - 3. RTPCR Samples collected at private hospitals/ labs and their designated collection centers 299/-
  - 4. RTPCR Samples collected through home visits 499/-
  - 5. Rapid Antigen Testing-350/-
  - 6. IgG based ELISA Testing-250/-
- The Government of Haryana has fixed the upper limited of lab test in patients of COVID-19/ post-COVID sequelae, as tabulated below:-

- Haryana Village General Health Checkup Scheme: The scheme was initiated from May 15, 2021 & villages with high COVID load were taken on priority and Rapid Antigen Testing (RAT) was the main stay of screening. Till date, total 1,73,79,228 were screened and 1,10,928 cases of ILI were detected and 5,164 positive cases were diagnosed, isolated and treated to prevent the spread of disease. The villages with positivity more than 5% were re-screened. Out of 13,22,058 people re-screened, 90 positive cases were detected and treated to effectively curtail the spread.
- Total 2637 number of Plasma Units collected from COVID 19 recovered patients till date and 1738 COVID 19 Patients given Plasma Therapy treatment till date.
- Control Room –cum- Helpline has been made operational at Panchkula. Services of tele-medicines are being provided through helpline. The helpline nos. are 8558893911, 1075 and 108 (Ambulance Services) available for 24 X 7.
- The State Government notified 'The Haryana Government Epidemic, COVID-19 Regulations, 2020' under the Epidemic Disease Act 1897 on 11<sup>th</sup> March 2020 and extended till 31<sup>st</sup> March 2022.
- Twenty Two Government Labs, one each at PGIMS, Rohtak (capacity 3000 sample per day) and BPS KhanpurKalan (2000 sample per day), ESIC Medical College Faridabad (2000 sample per day), KalpnaChawla Medical College Karnal (2000 sample per day), Civil Hospital, Gurugram (1800 sample per day), Civil Hospital, Panchkula (2500 sample per day), Command Hospital (150 sample per day), SHM, GMCH, Nuh (3000 samples per day), THSTI, Faridabad (500 sample per day), Civil Hospital, Ambala (2500 sample per day), MAMC Agroha, Hisar (2500 sample per day), Civil Hospital, Sirsa (1500 sample per day), Civil Hospital Rewari (1500 sample per day), CHC UCHANA JIND (1000 sample per day), Civil Hospital, Panipat (1500 sample per day), IMTECH, CSIR, Chandigarh (200 sample per day), Civil Hospital, Yamunanagar (2500 sample per day) and Civil Hospital, Bhiwani (1200 sample per day) District Lab, Faridabad (1000 sample per day), Civil Hospital, Charkhi Dadri (1000 sample per day), Civil Hospital, Molecular Lab, CHC Badopal, Fatehabad (750 sample per day), District Molecular Lab, CHC, Kalayat, Kaithal (750 sample per day) are for doing test for COVID-19 and Twenty Three Private Labs at CORE Diagnostics (5000 sample per day), Modern Diagnostic & Research Centre Lab, Gurugram (2500 sample per day), Dr. Lal Path Lab (3000 sample per day), SGT Gurugram (1500 sample per day), MolQ lab, Gurugram (1200 sample per day), Molecular Lab, Adesh Medical College and Hospital, Kurukshetra (2500 sample per day), AAL Research and Solution Pvt. Ltd., Panchkula (1500 sample per day), Spice Healthcare Pvt. Ltd., Gurugram (25000 sample per day), Pathline Labs Private Limited, Sec-63, Noida, UP (3500 sample per day), Life Cell International Pvt. Ltd., Gurugram (3000 sample per day), Hindustan Wellness Lab, Gurugram (6000 sample per day), CNC PathlabJhandewalla, Delhi (2500 sample per day), NC Medical College, Israna, Panipath (750 sample per day), AL FALAH Medical College Faridabad (400 sample per day) and Genestrings Diagnostic Centre, Delhi (4000 sample per day), Genestore Lab, Gurugram(40000 sample per day), THS Diagnostics, Okhla, New Delhi, Delhi (1000 sample per day), NKV Path Lab, Gurugram(2000 sample per day), Molecular Lab, Sarvodaya Hospital, Faridabad(1000 sample per day), Geneix Satya Laboratories, Faridabad (2500 sample per day), Med Source Ozone Biomedicals Pvt. Ltd., Faridabad (2000 sample per day), Pro Path Lab, Mayur Vihar, Delhi (2000 sample per day), Labcure Lab Pvt. Ltd., Rohini, Delhi (2000 sample per day), are doing test for COVID-19.
- More than 93.55 lac persons have already downloaded AarogyaSetu App in Haryana.
- More than 20 Mobile Health Teams have already been formed to check health status regarding SARI, ILI etc.
- Haryana has 36,858 bedded quarantine facilities in Dedicated COVID Care Centers and 28,182 Beds are available in Dedicated COVID Hospitals and in Dedicated COVID Health Centers.
- Department of Ayush has distributed immunity boosting medicines to more than 12.19 lac persons in containment zones.
- Home Isolation Kits Distributed till 28<sup>th</sup> December 2021: 38805 (Details provided by National Health Mission, Haryana).
- Sero Survey- Health Department, Haryana has conducted 3<sup>rd</sup> round of Sero Survey in the month of September 2021 in the State, wherein Seroprevalence was found to be 76.3 % (Urban 78.1 % & Rural 75.1 %). In previous 2 rounds, the Sero prevalence was found to be 8% in 1<sup>st</sup> round and 14.8% in 2nd round of Sero Survey.
- Govt. of Haryana has made 2<sup>nd</sup> dose compulsory for which detailed guidelines have been issued to all Deputy Commissioners on 22 December 2021.
