OFFICE ORDER

MISSION DIRECTOR (NHM)

With the expansion of the testing protocol as dicculated vide letter no NHMHP-IDSP/1/2020-IDSP-Section-NATIONAL HEALTH MISSION-HP-Part(3)-2728 dated 21st March 2020, it is expected that there will be increased number of the persons who will require testing for COVID-19. To meet with this enhanced demand, following protocol shall be followed:

- 1. Dedicated teams with one Medical Officer, One Lab Technician/Paramedic and two police personnel will be constituted to collect samples from the homes of the all symptomatic healthcare workers and all asymptomatic direct & high risk contacts of a confirmed case who need to be tested once between day 5 and day 14 after the last contact in each district.
- 2. Every district will get two-four medical officers and two-four Lab Technicians/Paramedics trained to do the sampling as per the requirement.
- These training will be imparted for District Kangra, Chamba, Hamirpur, Una, Kullu, Mandi and Lahaul at Dr RPGMC Tanda and for Districts Shimla, Bilaspur, Sirmour, Kinnaur, Solan and Spiti at IGMC Shimla.
- 4. Every District will provide a dedicated vehicle for movement of this team either from available pool of vehicles/Ambulances with them or they may hire a vehicle for this purpose.
- This team will be provided with all the required consumables in terms of the personal protective equipments required as per protocol and the necessary items required for collection and packing of the samples as per bio-safety standards.
- 6. This team will move to the homes of all the persons whose samples are to be collected as per testing protocol in vogue.
- 7. Collected and packaged samples shall be sent to the notified laboratories i.e. IGMC Shimla and Dr. RPGMC Tanda (at present) from the respective districts attached with these institutions by the concerned Chief Medical Officer.
