
**Subject Constitution of Committees under Disaster Management Act 2005**

The pandemic of COVID 19 has engulfed the entire world posing serious challenges for the health and economic security of millions of people worldwide. During this unprecedented situation for effectively addressing issues, constraints and scenarios a well planned and coordinated emergency response has become essential.

Measures have been taken in the State as per the guidelines issued by Ministry of Home Affairs on 24-03-2020 and subsequent addendums issued on 25-03-2020 and 27-03-2020 pertaining to measures to be taken by Ministries / Departments of Government of India, States/Union Territory Governments and State / Union Territory Authorities for containment of COVID-19 Epidemic in the Country.

Effective coordination among all agencies is vital to deal with this health emergency. Keeping in view the need for such integrated response, in exercise of the powers conferred under the section 24 (e) (f) and (l) of the Disaster Management Act, 2005, the undersigned in his capacity as the Chairman, State Executive Committee hereby constitutes Committees of officers (as per appendix) to deal with various aspects of COVID 19 management and containment.

The committees shall monitor on a daily basis, identify problem areas and provide effective solutions for time bound implementation of plans/decisions/policies in their respective areas. The Committees will thus take coordinated steps to combat the pandemic including effective implementation of lockdown and such other necessary measures as required.


