	Help in establishing decentralised sample collection and transportation system scientifically with WISKS and Mobile Collection centres

	For the outbreak in covid hospital and other outbreaks among health staff and community level (clusters), proper outbreak investigation report to be prepared daily and provide technical inputs to the field teams.



	Boarder area covid surveillance Plan; Considering the fact that district is sharing long boarder area, with so many formal and informal passages, after the lockdown relaxation, many people are going to nearby districts on a regular basis, covid surveillance , sample testing and ensuring reverse quarantine in these areas are very significant in this phase of epidemic control .
	Additional sample collection of ILI of peripheral institutions and other high risk groups to be followed up
	Non Covid CD; Review of Non Covid Communicable diseases, to be done regularly.

	Covid hospital – CFLTC planning and further expansion to be followed up
4	Human resource Related
	Mechanisms for motivation of Covid duty staff IT supported regular video conference system, non-monitory incentive, issuing of certificates etc
	Hiring adequate HR

5	Covid fund and SDRF Finance management
	Finance committee and follow up. Use delegated powers and get things done which are immediately required as per the guidelines already issued.
6	PHC/FHC/CHC & peripheral health institution related
	Covid works: Contract tracing, systems for ensuring home quarantine, providing NCD & mental health services in periphery monitoring
	Line list of contacts and follow up details to be prepared in excel sheets, and now in Covid Jagratha portal
	Systems for mobilising Sentinel sample collection
	In addition to the Covid Jagratha portal entry of cases, health workers and ASHAs are picking up unauthorised travellers coming to their areas and data entry of these cases to be done Covid Jagratha portal and put them on quarantine .



	For increasing sample collection in the district do planning to establish swab collection facilities in peripheral institutions in a phased manner.

	Need for an action plan for expansion of non Covid speciality services – surgeries and other medical surgical interventions in THQS & DH/GH.
