GAD-Covid-19 – general lock down- deployment of staff in General Administration Department-orders issued

Order

Guidelines for staff arrangement in each Department has been ordered as per Government Order read above. Based on the above, following deployment of staff are ordered in General Administration Department to facilitate the smooth conduct of Covid-19 containment activities:

- 1 General Administration (Secret Section) Department and General Administration (Political) Department will be in charge of the general administration of Government Secretariat. All general instructions connected with the Covid-19 activities will also be managed here.
- One Officer and 3 staff each may be made in to a group and given duty on alternate three days for managing general administration. One group 'A' officer and one group 'B' or 'C' officer shall invariably be present in office every day.
- Three officers and four assistants may be given charge of logistical and infrastructure arrangements for Kovid-19 War Room that has been set up in the South Conference Hall. They need to come to office only as per requirement that too only two at a time.
- 4 Joint Secretary, House Keeping Cell will ensure the general cleaning and sanitization of entire areas, where staff are present, on regular intervals.
