Chuvangin a chunga sawi **Sorkar-in Dt. 21.06.2020-a lockdown order a chhuah hi Lunglei District-ah Dt.23.6.2020 - 30.6.2020 chhung atan hman tur a ni a, Order-in a sawi inkaihhruaina zawng zawngte zawm vek tur a ni.**

He Order chungchanga hriattur pawimawh zual a hnuiah hian tarlan a ni.

1. Sorkar thupek chhuahin dawr inhawn a phalsakte chauh an inhawng thei anga. Dawr inhawn phalsakte an inhawn dan tur chungchangah **Village Level Task Force (VLTF)-in an area chhung atan ruahmanna an siam anga.** An ruahmanna siam dan chu Deputy Commissioner & Chairman, District Level Task Force, Lunglei District hnenah an thehlut ang.
2. Lockdown order-in pawnchhuah a phalsakte ni lo chu pawnchhuah phal a ni lova. Lirthei hmanga mipui chetvel khap a ni. Sorkar order-in a phalsakte erawh a huam loveng. **Tul bika pawnchhuak tur chuan mahni awmna VLTF phalna an la hmasa tur a ni.** VLTF-in chhuah phalna a pek hian lirthei-a an chhuah phalna pawh a keng tel thei nghal ang.
3. Pawn chhuak reng reng leh Dawr hmuna awmten heng Sorkar thupek leh inkaihhruainate hi an zawm ngei tur a ni.
 - a) Face mask emaw hmanraw dang hmangin hmai tuam an tur a ni.
 - b) Mi 3 aia tamin dawr pakhat an nghak tur a ni lova, wholesale dawr leh dawr lian (Departmental Store)-ahte chuan mamawh dan azirin godown/store lama thawktu nen mi 6 thleng chhawr theih a ni anga, a zat tur chu dawr awmna veng VLTF in a bituk ang.
 - c) Dawr nghaktu ten face mask an hmang reng tur a ni a, kut silfai an uar tur a ni.
 - d) Dawr neituten dawrtu turte dinna tur, metre hniih kar danah an rin lawk tur a ni a, dawr chhungah pawh metre hniha inhlatin an awm tur a ni.
