Hemi hre reng hian Sawrkarin Vegetable Supply Chain a duang chhuak ta a ni. District tinah DC hova hma la tura tih a ni a. Aizawl District bikah chuan hemi atan hian Horticulture Department chu Nodal Department ah dah niin, Commerce & Industries Department leh MIZOFED te nena thawk ho tura tih a ni. Kuthnatawktu ten an thlaithar rawn kente atangin sum an hmuh nghal zel a ngaih avangin leh tun dinhmunah kuthnathawktuten ei leh bar tur, nitin chakkhai leina an mamawh avangin an thlai thar rawn thawn ang hi man pek tlak zel an ngai a. Chuvangin MIZOFED chu an rawn ken ang apiang chu sumfai pe zel tura tih an ni.

Heti a nih avang hian Committee chuan kuthnathawktute hmakhua ngaiin Kg ah Rs. 25 in a laksak a ni. Tin, 15% a sangin Local Level Task Force (LLTF) ah pek chhuah leh a ni. LLTF te senso ngaihtuahin Kg ah Rs. 40 aia to lova hralh tura tih an ni. Chutiang bawkin Bawkbawn pawh kg khatah Rs. 25 a laksak an ni a, hei hi 15% a sanga pek chhuah an ni. Chu mai bakah thlaithartu intelkhawm, Agriculture and Horticulture Cooperative Society, Serchhip atangin vawiin 4/4/2020 hian Mizoram sawrkar hmalakna chungah lawmthu sawina an chhuah bawk.
