The Healthcare personnel i.e. Doctors, Paramedics and Class-IV employees are engaged in COVID health facilities such as dedicated COVID Hospitals /COVID Health Centres/COVID Care Centres in the State for treatment and care of COVID-19 positive patients.

After careful consideration, Government have been pleased to approve the incentive for the Doctors, Paramedics and Class-IV employees engaged in the aforesaid facilities as follows:

Sl. No.	Categories of Employees	Rate of Incentives per day
1	Doctors	Rs.1000/-
2	Paramedics ( Staff Nurse/ Pharmacists/ Radiographers/ Laboratory Technician)	Rs.500/-
3	Class.IV employees	Rs.200/-

These above categories of employees are entitled to avail the incentives for those days in which they are in active line of duty in contact with COVID positive patients in COVID health facilities.

The expenditure for the same will be met out of CMRF.




