In view of identification of 17 Positive cases of COVID-19 in the Embalam and Karikalampakkam Revenue Village pertaining to this Taluk jurisdiction on 17.04.2021, the following houses have been declared as Containment Zone.

Sl.No.	Revenue Village	Address
1	Embalam	No.6, Balamurugan Nagar Extension, Embalam.
2.	Karikalampakkam	10, V Corss , Rajiv Gandhi nagar, Karikkalampakkam

All vehicular movement, movement of public transport and personnel movement has to be restricted. All roads connecting the containment zone shall be guarded by the police with clear Entry and Exit Points. Movement of persons allowed only for maintaining supply of goods and services and for medical emergencies. A record may be maintained about the details of people moving in and out of perimeter.

The Medical Officer shall carry house to house surveillances by special team and clinical management of all cases as per protocol.

The Commissioner, Nettapakkam Commune Panchayat shall arrange to disinfect the entire area with 1% Sodium Hypochlorite Solution and make mike publicity.

Golf

The Revenue Inspector, Nettapakkam Firka shall make necessary arrangement to ensure availability of essentials viz. vegetables, groceries and milk to the people at their locality.

The Executive Engineer (B&R) (South), PWD shall make arrangement for barricading around the containment zone to prevent movement of people. The Revenue Inspector shall identify the location.

Hence, it is requested for appropriate action and continuous monitoring in the containment zone so as to control the spread of the infectious COVID-19 disease.
