### <u>ORDER</u>

#### \*\*\*

In view of the resurgence of the COVID-19 Positive cases in Puducherry region, it has been decided to form Enforcement Teams in order to enforce the COVID-19 preventive measures such as wearing masks, compulsory home quarantine of COVID-19 positive cases, maintaining social distancing etc., by the general Public.

2. Therefore, upon the powers conferred under Section 30 of the Disaster Management Act and Section 2, 3& 4 of the Epidemic Diseases Act, 1897, it is hereby ordered that the Officials mentioned in the Annexure, A are attached with the Tahsildar, Taluk Office mentioned against each, with immediate effect, until further orders. Each team will be accompanied by two Police Constables in Uniform. The teams shall strictly enforce COVID-19 appropriate behaviour and use of masks and ensure social distancing.

3. Further, for the use of these enforcement teams, vehicles along with drivers as shown in the Annexure B are also attached with the concerned Taluk Tahsildar, with immediate effect.

4. Therefore, all the Heads of Departments/Offices concerned shall relieve the concerned Official, Vehicles/Drivers immediately, with instructions to report before the concerned Taluk Tahsildars.

5. The Tahsildar, Taluk Office concerned shall deploy the teams Firkawise and coordinate the enforcement efforts. The Sub-Divisional Magistrate concerned shall have overall supervision and daily report shall be furnished as per Annexure `C'.
