ORDER

(U/S 34 of the Disaster Management Act, 2005)

In continuation to Order No. 1833/DC(E)/2020 dated 02/05/2020 regarding evacuation of stranded persons from different parts of the country, I, Raj Yadav, IAS, District Magistrate cum Chairperson, District Disaster Management Authority, East Sikkim hereby direct the following:

- A. The following centres have been identified for free facility quarantine in the district in Phase II and shall be under the overall supervision of the concerned Sub Divisional Magistrate:

C. All the directions mentioned in Order No. 1833/DC(E)/2020 dated 02/05/2020 and Order No. 1837 /DC(E)/2020 dated 07/05/2020 shall be strictly complied by all returnees and officials concerned.

D. Any hotels desirous of using their properties as paid facility quarantine centres shall register themselves with the Nodal Officer by sending a message with their details at 8287480648.

E. After the testing of returnees who are placed under facility quarantine is conducted by the concerned Medical Team, the returnees shall be advised to be under home quarantine based on the result of the tests. Sh. Mahesh Sharma, Joint Secretary, Roads & Bridges Department (shall be the Nodal Officer to facilitate the transportation and shifting of the returnees from the institutional/facility quarantine centres to home quarantine in coordination with concerned BDOs.

Any person violating these directions will be liable to be prosecuted against as per the provisions of Disaster Management Act, 2005, besides legal action under section 188 of the IPC, and other legal provisions as applicable.
