ORDER:

The World Health Organization has declared COVID-19 as a pandemic. COVID-19 has been declared as a notified disease under the Tamil Nadu Public Health Act, 1939. Further it has also been notified under the Epidemic Diseases Act, 1897. Restriction on movement of general public has also been imposed from time to time under the Disaster Management Act, 2005.

- 2. In order to monitor the preventive measures taken against the spread of COVID-19 closely, the State Government has taken various steps to control the spread of the disease. In the GOs first to third read above the Government had constituted twelve Co-ordination Teams to deal with the difficulties arising out of the restrictive / prohibitory measures. In the GO fourth read above the Government constituted "Zonal Special Task Team" comprising of senior IAS and IPS Officers, to co-ordinate as the District Administration to ensure effetive implementation of various guidelines issued by the Government.
- 3. The Hon'ble Chief Minister, while reviewing the works done by the twelve Co-ordination State level Teams, has advised to depute Officers from IAS, IPS/Tamil Nadu Police officers, District Revenue Officers and Officials from Local Body and Health and Family Welfare Department to co-ordinate with the concerned District Administration / Local Administration in the Districts viz. Chennai, Tiruppur, Coimbatore, Madurai and Salem.

- 4. Accordingly, the Government constitutes the "Field Support Team" comprising of officers IAS,IPS/Tamil Nadu Police, District Revenue Officers and officers from Local Body and Health and Family Welfare Department for Chennai, Tiruppur, Coimbatore, Madurai and Salem Corporations. The Team will assist the District Administration / Greater Chennai Corporation to ensure management of containment zones, provision of essential services in the containment area, contact tracing and testing etc, in the said Districts as Annexed to this Order. The District Collectors are requested to brief the team and co-ordinate the efforts of Field Support Teams in the Municipal Corporation Areas.
- 5. In view of the ongoing restrictive / prohibitory measures, the officers are permitted to make use of their staff cars for the visit to the attached Districts.
